The Potential Results

FAQ

- Q. Can anyone be energy assessed?
- A. No, This is not a residential energy assessment so the premises will have to be a certain minimum size.
- Q. How much will it cost me?
- A. It all depends how big and complex your business premises is. Typically an energy audit can be as little as £1000 where 50% (£500) is supported by IOM Gov.
- Q. How long will it take?
- A. Like the previous question it all depends how big and complex your premises are. Typically no longer than half a day.
- Q. Will I be recommended something that I won't get payback for 20 years?
- A. No, although we will include them, they will not be high on our list of recommendations.
